To Whom It May Concern or Special Agent:

I/we assume that that the 10-day clock has started for an objection to be filed but given a potential inability to obtain **and explain** the finding or agreement, Diane has been told to simply mail a check for the \$445 she ultimately understood was for May 2025 (with any necessary adjustment set for June) and any understanding as to the other amounts about which I was uncertain beyond \$744 was no longer an amount to consider but \$650 was to have **possibly fit in someplace** (this is the hold-up as all Diane could repeat was "I do not have \$650" and "where am I going to get (that kind of money) from"? Answers I could not provide with necessary **specificity beyond the fact she would see something different for June.**

Hence, this will be mailed separately from the check amount to serve in the tribunal's discretion as an objection and a necessary rescheduling of the hearing or as mentioned during the 'conference' the absence of a title II office at PP&L and the Commission means the involvement of Lawyers who ensure (1) fees are paid and (2) their involvement is necessary (imagine if some person from PP&L in a Title II Office for elderly patrons could explain all of this slowly taking the 90 minutes at a fraction of the cost involved prior to the conference?

Again, thanks to all involved in the proceedings and please see enclosed letter meant to be sent immediately prior to the hearing.

I/we assume that the Special Agent is aware of the attempts to communicate which included asking that opposing counsel find a way to timely get the matter before this tribunal given the availability of electronic filing links. If not, I/we ask that it be permitted at the start of the hearing in this matter as this letter will come from one of my sons whom Diane knows well.

Ultimately, the matter concerns Diane Lewis and her ability to obtain trusted representation. Hence, ultimately, the issue becomes in terms of setting a hearing what accommodations to include a representative of choice is the Special Agent and PPL Electric Utilities Corporation prepared to make under the Americans with Disabilities Act to ensure Diane Lewis obtains every measure of accommodations from communication with this tribunal to communication to and from the referenced defendant. If the answer is 'none are forthcoming' then this letter should serve as an appeal of any determination by this tribunal.
