Dear Judge DeVoe:

Pursuant to Your Honor's directive at the May 9, 2025 Prehearing Conference, Laurel Pipe Line Company, L.P. ("Laurel" or the "Company"), and Monroe Energy, LLC ("Monroe"), Lucknow-Highspire Terminal, LLC ("LHT"), Sheetz, Inc. ("Sheetz") and PBF Holding Company LLC ("PBF"), collectively, the "Complainants," conferred to determine if they could agree to a procedural schedule in this matter. However, they were unable to do so.

As explained in Laurel's Prehearing Memorandum and based on the narrow scope of issues presented in this proceeding, Laurel proposes the following procedural schedule be adopted in this matter.

Prehearing Conference	May 9, 2025
Complainants' Direct	June 11, 2025
Laurel Rebuttal	July 1, 2025
Hearing	July 7-9, 2025
Main Brief	July 23, 2025
Reply Brief	July 31, 2025

Laurel believes that this schedule is appropriate for the same reasons it discussed in its Prehearing Memorandum and at the Prehearing Conference. In addition, this schedule balances providing the Complainants with their request to submit written testimony with the opportunity to conclude this proceeding in a timely manner.


