This filing is a request for the **ADDITION** of Peak Season local hourly rates and the **ADDITION** of Peak Season packing rates.


The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

NOTE 1 - MINIMUM TRANSPORTATION CHARGES: Sundays & Holidays (any hour): 5 hours at rates named in Columns 1 and 2.

Other than Sundays & Holidays (any hour): Non-Peak Season (November 1st thru April 30th): 4 hours at rates named in Columns 1 and 3.

Other than Sundays & Holidays (any hour): Peak Season (May 1st thru October 31st): 5 hours at rates named in Columns 1 and 3.

NOTE 3 - WAIVER OF MINIMUM CHARGE - CARRIER CONVENIENCE

Carrier shall not assess a minimum charge (number of hours) whenever a move requires less than the minimum number of hours filed and said move is performed solely at the carrier's convenience. In such instances, the carrier shall charge based on the actual time required to complete the move plus applicable travel charge.

NOTE AA - A flat charge based on one hour at the applicable transportation rates shown in columns 2 or 3 when distance from the original point of origin to the final destination is 20 miles or less.

A flat charge based on one and one half hours at the applicable transportation rates shown in Columns 2 or 3 when distance from the original point of origin to the final destination is more than 20 miles but not exceeding 30 miles.

A flat charge based on two hours at the applicable transportation rates shown in Columns 2 or 3 when distance from the original point of origin to the final destination is more than 30 miles but not to exceed 40 miles.
