

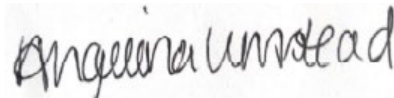

**PRELIMINARY OBJECTION TO  
THE COMPLAINT OF CLARENCE GOTTSCHALL AND TONYA SHANER**

TO THE PENNSYLVANIA PUBLIC UTILITY COMMISSION:

AND NOW, FirstEnergy Pennsylvania Electric Company (“FE PA” or the “Company”), on behalf of its Met-Ed Rate District,<sup>1</sup> by and through Angelina Umstead, files this Preliminary Objection pursuant to Section 5.101(a) of Pennsylvania Public Utility Commission (“Commission”) regulations, 52 Pa. Code § 5.101(a)(1), and in support thereof, avers as follows:

**I. Introduction**

1. In their recently filed Formal Complaint, Clarence Gottschall and Tonya Shaner (“Complainants”) allege they sustained damages to personal property located at 1412 Mountain Road, Hamburg, PA 19526 (“Service Location”) as a result of the Company’s vegetation management work. The Complainant requests that FE PA financially compensate them for alleged damage to their pond.

2. As explained below, the Commission does not have the power and legal authority to award monetary damages. As a result, the Company requests that this Preliminary Objection

Due to the merger transaction, the affected operating companies’ tariffs were consolidated into a single tariff, with each former operating company's rates becoming its own rate district. be granted and that the Commission: (i) grant its Preliminary Objections and strike the Complainant's request for monetary damages; (ii) expressly prohibit the Complainants from introducing any testimony or exhibits at any evidentiary hearing regarding alleged damages; (iii) dismiss the Formal Complaint in its entirety with prejudice; and (iv) grant the Company such other relief as may be just and reasonable under the circumstances.

## **II. Background**

3. The Company is an electric distribution company certificated as a public utility permitted to operate within the Commonwealth in Pennsylvania.

4. The Complainant filed a Formal Complaint with the Commission against the Company at the above-captioned docket requesting that the Commission direct the Company to financially reimburse the Complainant for damages incurred to their pond.<sup>2</sup>

5. On May 1, 2025, the Complainants filed a Formal Complaint with the Commission against the Company at the above-captioned docket.

6. The Company is timely filing its Answer and New Matter contemporaneously with this Preliminary Objection, which Answer and New Matter is incorporated into this Preliminary Objection as if fully set forth herein.

## **III. Argument**

7. The Commission's Rules of Practice and Procedure permit parties to file preliminary objections. The grounds for preliminary objections are limited to those set forth in 52 Pa. Code § 5.101(a) as follows:

- (1) Lack of Commission jurisdiction or improper service of the pleading initiating the proceeding.
- (2) Failure of a pleading to conform to this chapter or the inclusion of scandalous or impertinent matter.

- (3) Insufficient specificity of a pleading.
- (4) Legal insufficiency of a pleading.
- (5) Lack of capacity to sue, nonjoinder of a necessary party or misjoinder of a cause of action.
- (6) Pendency of a prior proceeding or agreement for alternative dispute resolution.
- (7) Standing of a party to participate in the proceeding.

8. The Commission's procedure regarding the disposition of preliminary objections is similar to that utilized in Pennsylvania civil practice.<sup>3</sup>

9. The Commission's procedural regulations allow a party to object to pleadings that fail to comply with the rules of administrative practice or that include scandalous or impertinent matters.<sup>4</sup>

10. In their Formal Complaint, the Complainants state the following as his request for relief: "Pay to fix/overlay concrete on pond/stone to repair."<sup>5</sup>

11. Clearly, the only relief sought through the Formal Complaint is an award of monetary damages from the Company.

12. It is well-established under Pennsylvania law that the enforcement powers of the Commission do not include the power to award money damages.<sup>6</sup>

13. In *Feingold*, the Pennsylvania Supreme Court explained:

. . . the statutory array of PUC remedial and enforcement powers does not include the power to award damages to a private litigant for breach of contract by a public utility. Nor can we find an express grant of power from which the power to award such damages can be fairly implied. Thus, it can be concluded that the Legislature did not intend for the PUC to have such a power.<sup>7</sup>

14. A prayer for damages which are not legally recoverable in the cause of action is “impertinent matter” in the sense that it is irrelevant to that cause of action and is correctly challenged through a motion to strike the requested relief as impertinent matter.<sup>8</sup>

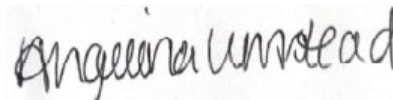
15. Therefore, in accordance with Pennsylvania law, this Commission does not have the power to award monetary damages, and the Complainant’s request for money damages is an impertinent matter that must be stricken.

**IV. Conclusion**

WHEREFORE, for the foregoing reasons, FirstEnergy Pennsylvania Electric Company respectfully requests that the Commission: (1) grant its Preliminary Objections and strike the Complainant’s request for monetary damages; (2) expressly prohibit the Complainants from introducing any testimony or exhibits at any evidentiary hearing regarding alleged damages; (3) dismiss the Formal Complaint in its entirety with prejudice; and (4) grant the Company such other relief as may be just and reasonable under the circumstances.


