



Bills on allowing headphones, lifting lifetime CDL bans moves

HARRISBURG – Motorcycle riders would be allowed to wear Bluetooth-enabled helmets and related devices under a bill that cleared the Pennsylvania House Transportation Committee Tuesday.

Members also voted to advance a bill laying the groundwork for those with lifetime suspensions of commercial driver's licenses to have their privileges reinstated.

The bill concerning headphones, House Bill 646, was reintroduced by state Rep. Zach Mako, R-Northampton.

It would permit the use of wireless headsets, earbuds and helmets with built-in speakers, that a majority of riders use and should not be penalized for.

"Currently, under Commonwealth statute, a motorcycle rider is only able to wear a headset that provides sound through one ear in conjunction with a cellphone or other communication device. I believe this law should be updated to better reflect the times," Mako wrote in a cosponsorship memo.

PennDOT is neutral on the bill. It's supported by the motorcycle riders' alliance ABATE and opposed by the Pennsylvania Chiefs of Police Association.

Introduced last session, too, it cleared the House in April 2024 by a vote of 198-2, but was never brought up for consideration in the Senate before the session expired.

"It actually puts helmets on people. We see people riding up and down highways across the commonwealth with no helmets at all," said state Rep. Ed Neilson, D-Philadelphia, majority committee chair.

The bill advances to the House floor by a vote of 25-1.

House Bill 960 from state Rep. Carol Hill-Evans, D-York, is also reintroduced from last session after easily being approved by the House, 155-48.

The bill would create conditions for CDL lifetime bans to be lifted. Hill-Evans cites a need for commercial truckers.

"In a nation where freight is essential to the movement of goods and the strength of our economy, we cannot afford to overlook capable, rehabilitated drivers," she wrote in her cosponsorship memo.

At least 10 years of lifetime disqualification must have

passed before one is eligible for reinstatement. Anyone seeking reinstatement must also not have been convicted of any disqualifying offenses in the prior 10 years, including drunken driving. They must also complete an approved driver improvement course, meet all existing CDL requirements and if their ban was instituted because of drunken driving or refusing to consent to a blood-alcohol test, they must complete an approved rehabilitation plan.

Anyone whose license would be reinstated would again be subject to a lifetime ban upon conviction of certain offenses, including accidents involving death or personal injury and driving under the influence.

Those convicted of felony drug offenses, human trafficking, three or more DUIs and fleeing the scene of a fatal accident wouldn't be eligible for reinstatement.

Wall Street rallies, recovers as dollar, U.S. bond market steady

NEW YORK – U.S. stocks jumped in a widespread rally Tuesday, and other U.S. investments steadied a day after falling sharply on worries about President Donald Trump's trade war and his attacks on the head of the Federal Reserve.

The S&P 500 climbed 2.5%. The Dow Jones Industrial Average rose 1,016 points, or 2.7%, and the Nasdaq composite gained 2.7%. All three indexes more than made up their big losses from the start of the week.

The value of the U.S. dollar also stabilized after sliding against the euro and other competitors, while longer-term Treasury yields held steadier as more calm returned to financial markets. Sharp, unusual moves for the dollar and for Treasuries have recently raised worries that Trump's policies are making investors more skeptical about U.S. investments' reputation as the world's safest.

The only prediction many Wall Street strategists are willing to make is that financial markets will likely continue to veer up and down as hopes rise and fall that Trump may negotiate deals with other countries to lower his tariffs. If no such deals come quickly enough, many investors expect the economy to fall into a recession.

The International Monetary Fund Tuesday slashed its forecast for global economic growth this year to 2.8%, down from 3.3%. But Vice President JD Vance also said he made progress with India's prime minister, Narendra Modi, on trade talks Monday.

A suite of better-than-expected profit reports from big U.S. companies, meanwhile, helped drive U.S. stocks higher.

Equifax jumped 13.8% after reporting a better profit for the first three months of 2025 than analysts expected. It also said it would send more cash to its shareholders by increasing its dividend and buying up

to \$3 billion of its stock over the next four years.

3M climbed 8.1% after the maker of Scotch tape and Command strips said it made more in profit from each \$1 of revenue during the start of the year than it expected. The company also stood by its forecast for profit for the full year, though it said tariffs may drag down its earnings per share by up to 40 cents per share.

Homebuilder PulteGroup rose 8.4% after it likewise delivered a stronger profit for the start of 2025 than analysts expected.

It's been benefiting from some of the sharp moves in the bond market. Drops for Treasury yields during the first three months of the year translated into lower mortgage rates for potential customers, though yields have been largely rising since early this month.

CEO Ryan Marshall said buyers "remain caught between a strong desire for homeownership and the affordability challenges of high selling prices and monthly payments that are stretched."
