- 1.) Based upon the information provided, it has been determined that the authority you wish to provide would fall under the category of Household Goods in Use. As such, if you still wish to obtain authority from this Commission you will need to do the following:
  - a. Submit a verified statement to the Commission requesting that you wish to amend your authority to that of Household Goods in Use.

  - c. A certified check, money order, or check from your attorney made payable to the “Commonwealth of Pennsylvania,” to make up for the difference (\$250) between the filing fee of Property (\$100) and that of Household Goods in Use (\$350).
