Dear Ms. Salamone,

PECO is aware that **Renewable Strategy Partners Inc.** has applied for a license to provide brokering and consulting services to residential, commercial and industrial customers on the distribution system of PECO.

In making such an application, **Renewable Strategy Partners Inc.** could be required to provide to PECO a bond or other acceptable financial security in an amount that PECO determines to be appropriate. **Renewable Strategy Partners Inc.** has indicated that it intends to provide ONLY brokering and consulting services to residential, commercial and industrial customers and will not take title to any delivered natural gas; nor will accept any customer payments or deposits. Therefore, PECO has determined currently that **Renewable Strategy Partners Inc.** does not need a bond or other financial security requirement, since they are not directly engaging in business with PECO and only providing brokering or consulting services to PECO customers. However, if the services provided by **Renewable Strategy Partners Inc.** or the creditworthiness requirement for PECO's exposure to **Renewable Strategy Partners Inc.** changes in the future, PECO reserves the right to require **Renewable Strategy Partners Inc.** to provide a bond or other financial security instrument.
