INTERIM ORDER
CONSOLIDATING FORMAL COMPLAINTS

On February 24, 2025, Gloria Holloway (“Ms. Holloway”) filed a Formal Complaint against Community Utilities of Pennsylvania Inc. (“CUPA”) – wastewater division with the Pennsylvania Public Utility Commission (“Commission”). Also on the same date, Ms. Holloway filed an identical Formal Complaint against CUPA – water division. In the Formal Complaints, Ms. Holloway alleged that CUPA was price gouging and overcharging her for her wastewater and water service and for relief requested that the Commission look into this alleged price gouging by CUPA. An Answer, New Matter, and Preliminary Objections have been filed against the Formal Complaints by CUPA.

Through this Order, the undersigned will consolidate the two Formal Complaint proceedings. The Commission’s regulations address the consolidation of proceedings as follows:

§ 5.81. Consolidation.

(a) The Commission or presiding officer, with or without motion, may order proceedings involving a common question of law or fact to be consolidated. The

Commission or presiding officer may make orders concerning the conduct of the proceeding as may avoid unnecessary costs or delay.

52 Pa. Code § 5.81(a).

As the two Formal Complaints are completely identical, it is clear that the Complaints contain common questions of law and fact. Consolidation therefore will avoid unnecessary costs or delay to the parties and the Commission. Accordingly, the Complaints will be consolidated in the Ordering paragraphs below.

ORDER

THEREFORE,

IT IS ORDERED:

1. That Docket Nos. C-2025-3053873 and C-2025-3053874 are consolidated.
