

## NOTICE OF MOTOR CARRIER COMPLAINT

- A. You must file an Answer within twenty (20) days of the date of service of this Complaint. The date of service is the mailing date as indicated at the top of the Secretarial Cover Letter for this Complaint and Notice, 52 Pa. Code §1.56(a). An Answer is a written explanation of circumstances wished to be considered in determining the outcome. The Answer should raise all factual and legal arguments that you wish to claim in your defense and must include the reference number of this Complaint. Your Answer must be verified and the original **mailed to:**

- B. If you fail to answer this Complaint within twenty (20) days, the Bureau of Investigation and Enforcement will request that the Commission issue a Secretarial Letter imposing a penalty. The penalty could include a fine, the suspension or revocation of your certificate of public convenience, or other such remedy.
- C. You may elect not to contest this Complaint by paying the fine proposed in this Complaint by certified check or money order. **Payment must be made to "Commonwealth of Pennsylvania"** and forwarded to:

- D. Your payment is an admission that you committed the alleged violation and an agreement to cease and desist from further violations. Upon receipt of your payment, the Complaint proceeding shall be closed.
- E. If you file an Answer, which admits or fails to deny the allegations of the Complaint, the Bureau of Investigation and Enforcement will request that the Commission issue a Secretarial Letter imposing a fine and/or other such remedy.
- F. If you file an Answer which contests the Complaint, the matter will be assigned to an Administrative Law Judge (ALJ) for hearing and decision. The ALJ is not bound by the optional fine set forth above.

**MOTOR CARRIER COMPLAINT**

The Pennsylvania Public Utility Commission (“Commission” or “PUC”) is a duly constituted agency of the Commonwealth of Pennsylvania empowered to regulate public utilities within the Commonwealth. The Commission has delegated its authority to initiate proceedings which are prosecutory in nature to the Bureau of Investigation and Enforcement and other bureaus with enforcement responsibilities. Pursuant to that delegated authority and Section 701 of the Public Utility Code, the Bureau of Investigation and Enforcement – Motor Carrier Division hereby represents as follows:

1. That YOURWAY TAXI AND LIMO INC, Respondent, maintains its principal place of business at 6681 Snowdrift Road, Allentown, PA 18106.

2. That Respondent was issued a certificate of public convenience for airport transfer authority on August 24, 2018, limousine authority on August 24, 2018, and taxi authority on August 24, 2018, by this Commission at PUC Utility Code No. 6420836.

3. That on March 17, 2025, PUC Motor Carrier PUC Enforcement Officer Keith Fryslin conducted an annual inspection of vehicles and drivers’ records because of a consumer complaint lodged with the Motor Carrier Division.

4. At the time of inspection, Respondent employed five drivers.

5. The inspection determined that the Respondent failed to obtain and review a criminal history record from the Pennsylvania State Police prior to permitting all five drivers to operate a vehicle in its authorized service.

6. A review of the criminal history records of Respondent’s driver A.C., determined that A.C. was convicted of two felonies that adversely impacted A. C.’s suitability to provide safe service.

7. That Respondent, by failing to obtain and review criminal history records from the Pennsylvania State Police prior to employing five drivers to operate a vehicle in its service, has violated 52 Pa. Code § 29.505(a)(1). The penalty for this violation is two hundred and fifty dollars (\$250.00).

8. That Respondent, by permitting a person to operate a vehicle in its authorized service when the person was convicted of a felony or a misdemeanor under the laws of the commonwealth or under the laws of another jurisdiction to the extent the conviction relates adversely to that person’s suitability to provide service safely and legally, has violated 52 Pa. Code §29.505(a)(3). The penalty for this violation is one thousand dollars (1,000).

**WHEREFORE**, the Bureau of Investigation and Enforcement hereby requests that the Commission fine YOURWAY TAXI AND LIMO INC, one thousand two hundred fifty dollars (\$1,250.00) for the violations described in this Complaint and order such other remedy as the Commission may deem to be appropriate.
