PHILADELPHIA GAS WORKS' MOTION TO CONTINUE

Pursuant to 52 Pa. Code §1.15, Philadelphia Gas Works (“PGW”) hereby files this Motion to Continue the evidentiary hearing in this matter, which is scheduled for Monday, June 16, 2025. In support of this Motion, PGW states as follows:

1. By notice dated May 1, 2025, the Commission scheduled a hearing in this matter for Monday, June 16, 2025 at 10:00 a.m., before Administrative Law Judge Marta Guhl.
2. PGW is still in the process of investigating the issues raised in the Complaint and requires more time to complete its investigation.
3. Additionally, pursuant to 52 Pa. Code §5.231(a) and the Prehearing Order issued in this matter, PGW is working with the Complainant to reach a resolution in this matter.
4. PGW has spoken with Ms. Suarez to discuss this request to continue the hearing.
