**INTERIM ORDER
CLOSING THE RECORD**

On May 15, 2025, Mr. Richard Myers (Complainant) emailed the Office of Administrative Law Judge and parties a document titled Response to Interim Order (Response), which addressed the Interim Order Directing Scheduling of a Further Prehearing Conference that was issued on April 28, 2025. The certificate of service attached to the Response indicated that it was emailed and mailed to the Secretary of the Public Utility Commission (Commission) but was not electronically filed.

In his Response, the Complainant states “I petition herewith to withdraw my Formal Complaint dated January 19, 2024.”

By email sent on May 16, 2025,¹ I asked the parties to advise me by noon on May 20, 2025 if they objected to the prehearing conference being canceled and, further, whether there was any objection to treating the request in the Response as a petition for leave to withdraw the Formal Complaint.

The Complainant has not responded to my May 16, 2025 email or otherwise objected to my proposed treatment of the Response to Interim Order.

¹ On his Complaint form, the Complainant elected to receive all documents by email from the Commission.

By email sent on May 19, 2025, Devin T. Ryan, Esquire, counsel for PPL Electric Utilities Corporation (PPL) advised me and the Complainant that PPL does not object to a petition for leave to withdraw being granted.

On May 20, 2025, I advised the parties by email that the telephonic prehearing conference scheduled for May 21, 2025 was canceled. On May 21, 2025, the Commission issued a written notice confirming the cancelation.

On May 29, 2025, I was notified that the Secretary's Bureau had received and accepted for filing the mailed copy of the Response to Interim Order.

THEREFORE,

IT IS ORDERED:

1. That the record at Docket No. C-2024-3045577 is hereby closed.
2. That a decision in this case shall be prepared and issued.
