##### PENNSYLVANIA PUBLIC UTILITY COMMISSION NOTICE

Applications of Jamp Management Inc. for Approval to Offer, Render, Furnish or Supply Natural Gas Supply Services at Docket No. A-2025-3054388 and Electricity or Electric Generation Services at Docket No. A-2025-3054355 to the public in The Commonwealth of Pennsylvania.

Jamp Management Inc. has filed an application with the Pennsylvania Public Utility Commission ("PUC") for a license to provide natural gas supply services as a broker/marketer engaged in the business of supplying natural gas services.

Additionally, Jamp Management Inc. has filed an application with the PUC for a license to supply electricity or electric generation services as a broker/marketer engaged in the business of supplying electricity services.
