Detailed below are the answers to the data request dated April 30, 2025, pertaining to the application of the above carrier:

1a. The Applicant will conduct criminal history checks with the Pennsylvania State Police and every other state where the person has resided for the last 12 months for all initial hires. Thereafter the Applicant will obtain updated criminal history reports for all drivers on an annual basis or sooner if so required by contract. All criminal history records shall be maintained for five years at the address of the Applicant

1b. The Applicant will conduct a very intensive driver training program. Initial and recurrent training shall be given to every driver. This includes passenger assistance training, HIPAA compliance, defensive driving, wheelchair securement, CPR/First Aid and sensitivity training. All of this training will be conducted before a driver goes on the road and ongoing as necessary. Ongoing education in addition to retraining shall include virtual learning modules, in person instruction and regular safety briefings. The Applicant shall provide compliance tracking and documentation to ensure that all drivers remain up to date with regulatory and safety requirements. All initial drivers will also receive on the road training to put to use the training tools they have received before transporting passengers.

2. We have identified a cash balance in our balance sheet statement filed with our application. I have attached hereto as Exhibit A, a copy of a letter from the bank detailing our balance. The company, which will begin with one vehicle also has that vehicle in their possession but it is not titled as yet to them. Upon receipt of certificate the vehicle will be transferred to the Applicant. As such it has not been included in our balance sheet as of yet.
