- 1) Your previous answers were received, and were insufficient. You were instructed by phone to read Title 52 and cite time frame specific compliance requirements stated there, to reflect PUC expectations for collection and maintenance of records for drivers. Please re-read Title 52 and provide those specific requirements.

The responses to questions 5(a), 5(b), 5(c), 5(d) and 5(e) of the verified statements are insufficient. Title 52 Pa. Code § 29 provides detailed requirements. Please provide a system which incorporates code specific compliance requirements. Read Title 52, answers can be found there. Each of your answers to sections of this question were insufficient:

- § 29.503. Age restrictions.
- § 29.504. Driver history
- § 29.505. Criminal history.
