1. Your proposed service area is insufficiently clear. The area must be fully bound, and easily discernible. This may be achieved by the use of municipal boundaries, roads, railroads, or natural boundaries such as rivers and streams, etc. Vague terms such as, “city and county of Philadelphia and the surrounding counties” are unacceptable and insufficiently specific.

YOU SHOULD ONLY SPECIFY AREAS FROM WHICH YOU WISH TO ORIGINATE SERVICE.

Examples:

- a. between points in the counties of Chester, Delaware, and Montgomery.
 - b. from points in the counties of Chester, Delaware, and Montgomery, to points in Pennsylvania.
 - c. from points in the counties of Chester, Delaware, and Montgomery, to points in the counties of A, B, and C, and return
2. Please provide a more complete description of your previous experience managing the small non-medical transportation company. What is the company name and are they certificated with this Commission? Did the company transport people, or commodities? If commodities, what types and to whom did they belong? What were your periods of employment?
 3. Does LULU TRANSPORTATION, LLC, presently provide transportation service? If so, please provide a complete description of the services, locations serviced, and the goods/people transported.
 4. Your response to question #8 of the applicant’s verified statements is missing. Please provide information for insurance quotes you have received: include the providing company’s name, the quoted policy cost, and the quoted policy duration. Have you verified that your provider is capable of furnishing the Commission a Form E as evidence of coverage?

The purpose of the verified statement questions is to determine your ability to provide safe, efficient, and reasonable transportation. It is in your best interest to provide accurate, complete, and timely responses. Failure to do so is sufficient grounds to justify the denial of your application because YOU have failed to provide sufficient evidence of your fitness to operate.
