This letter is in response to the “Objection to Dismissal” and “Notice of Fault” filed by Edrie Fields (“Complainant”) and served upon Pennsylvania-American Water Company (“PAWC” or the “Company”) via email on June 5, 2025, and received via United States Postal Service (“USPS”) Certified Mail on June 10, 2025.
