**ORDER REGARDING RESPONDENT'S REQUEST
FOR A CONTINUANCE OF THE HEARING**

On June 3, 2025, counsel for PPL Electric Utilities Corporation (PPL) filed a Motion requesting a one-week continuance of the hearing scheduled for July 2, 2025, at 10:00 a.m. in the above-captioned matter. As reason for requesting the continuance, counsel cited her unavailability to appear on the hearing's scheduled date and time. In addition, the Motion mentions that, in email correspondence with the Complainant on May 19, 2025, Counsel for PPL Electric determined that the Complainant opposes the requested continuance.

I find that good cause exists to continue the scheduled hearing to another date. 52 Pa.Code § 1.15(b). PPL's request for continuance will be granted. The evidentiary hearing scheduled for July 2, 2025, will be cancelled and rescheduled for a later date.

THEREFORE,

IT IS ORDERED:

1. That PPL Electric Utilities Corporation's Motion for continuance of the scheduled hearing is granted.

2. That the evidentiary hearing scheduled for July 2, 2025, in the matter of *Edwin O'Connor v PPL Electric Utilities Corporation*, Docket No. F-2025-3054767 is cancelled and will be rescheduled for a later date.
