To Daniel Killmeyer:

Kindly be advised Peoples Natural Gas Company LLC, listed above, filed a Joint Petition for Settlement with the Pennsylvania Public Utility Commission in which all of the outstanding issues was resolved. The Company was joined in the Petition with the Commission's Bureau of Investigation and Enforcement, and the Office of Consumer Advocate. Two other parties - the Office of Small Business Advocate and the Pennsylvania Independent Oil & Gas Association – have indicated they do not oppose the Petition.

The parties to the Petition state they find the proposed settlement to be fair, just and reasonable, and in the public interest. In a separate mailing, the utility company provided to you a copy of that joint settlement, together with the parties' supporting statements. A copy was sent to you because you are a Formal Complainant in the case.

As the Administrative Law Judge, I must draft a decision recommending to the Commission whether to accept this settlement as in the public interest or reject it as contrary to the public interest. **If you have any comments regarding the Settlement, you must submit them by Thursday, June 26, 2025.**

Because you filed a Formal Complaint in this case, you have the following options:

- You may join in the proposed Settlement. Sign and return the Signature Page (enclosed with this letter) to me, **by Thursday, June 26, 2025**. Signing the Signature Page means that you agree to have your Formal Complaint discontinued with the approval of the proposed Settlement.
- You may object to the Settlement. You must submit written objections to me by letter **by Thursday, June 26, 2025**.
- You may choose to do nothing.
