**INTERIM ORDER  
DISMISSING PRELIMINARY OBJECTIONS**

Audrey Edwards (Complainant) filed a formal complaint naming Duquesne Light Company and Solar City n/k/a Tesla (Solar City) as respondents. The Complainant alleged, among other things, that her Duquesne Light meter has not been operating properly or recording her actual usage accurately. The Complainant also contended that her solar panel system is not operating properly, and that Solar City customer service has been unresponsive.

On May 19, 2025, Duquesne Light filed an answer denying the material allegations of the complaint as they relate to Duquesne Light’s meter, billing and service. Duquesne Light also filed preliminary objections seeking dismissal of the Complainant’s claims against Solar City.

On May 22, 2025, the preliminary objections were assigned to me for disposition.

On June 13, 2025, the Commission’s Secretary’s Bureau notified the Complainant that the Commission does not regulate Solar City, therefore the Commission is rejecting her complaint as it relates to Solar City as a respondent.

The Commission’s regulations permit the dismissal of claims because the Commission lacks jurisdiction to resolve those claims. 52 Pa. Code § 5.101(a). The June 13, 2025, Secretarial Letter essentially resolves Duquesne Light’s preliminary objection that the

Commission lacks jurisdiction over Solar City. Accordingly, the preliminary objections will be dismissed as moot.

THEREFORE,

IT IS ORDERED:

1. That the preliminary objections of Duquesne Light are hereby dismissed as moot.
2. That this matter shall be scheduled for hearing.
3. That the parties are reminded that Commission policy encourages settlement. 52 Pa. Code § 5.231.
