Everstream Solutions LLC ("Everstream") hereby provides notice to the Pennsylvania Public Utility Commission that it and certain of its affiliates filed a Petition under Chapter 11 of the Bankruptcy Code in the United States Bankruptcy Court for the District of Delaware on May 28, 2025, in Case No. 25-90144. The filing of the Petition served to convert the legal status of Everstream and its filer affiliates to debtors-in-possession. The bankruptcy filing did not result in any change to the current operations of Everstream, its address, or the terms and conditions of its service.




