
The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

NOTE 3 - Tolls and/or parking permits/tickets incurred by the carrier when transporting the shipment will be the responsibility of the shipper and added to the final charges. This note is applicable to moves transported 40 miles and less and moves transported in excess of 40 miles.

NOTE 4 - When requested or required, in lieu of storage, an overnight handling fee of **\$175.00** per truck per night will be assessed.

NOTE AA - A flat charge based on one hour at the applicable transportation rates shown in Columns 2 and 3 will apply if the road miles from the carrier's terminal to the point of origin and from point of destination to carrier's terminal total 30 miles or less. A flat charge based on two hours at the applicable transportation rates shown in Columns 2 and 3 will apply if the road miles from the carrier's terminal to the point of origin and from the point of destination to the carrier's terminal total 31-60 miles. Should the actual distance from the carrier's terminal to the point of origin and from the point of destination to the carrier's terminal exceed 60 miles, an additional charge based on one-half hour of travel time for each additional 15 miles increment will apply.
