

NOTICE OF MOTOR CARRIER COMPLAINT

- A. You must file an Answer within twenty (20) days of the date of service of this Complaint. The date of service is the mailing date as indicated at the top of the Secretarial Cover Letter for this Complaint and Notice, 52 Pa. Code §1.56(a). An Answer is a written explanation of circumstances wished to be considered in determining the outcome. The Answer should raise all factual and legal arguments that you wish to claim in your defense and must include the reference number of this Complaint. Your Answer must be verified and the original **mailed to**:

- B. If you fail to answer this Complaint within twenty (20) days, the Bureau of Investigation and Enforcement will request that the Commission issue a Secretarial Letter imposing a penalty. The penalty could include a fine, the suspension or revocation of your certificate of public convenience, or other such remedy.
- C. You may elect not to contest this Complaint by paying the fine proposed in this Complaint by certified check or money order. **Payment must be made to "Commonwealth of Pennsylvania"** and forwarded to:

- D. Your payment is an admission that you committed the alleged violation and an agreement to cease and desist from further violations. Upon receipt of your payment, the Complaint proceeding shall be closed.
- E. If you file an Answer, which admits or fails to deny the allegations of the Complaint, the Bureau of Investigation and Enforcement will request that the Commission issue a Secretarial Letter imposing a fine and/or other such remedy.
- F. If you file an Answer which contests the Complaint, the matter will be assigned to an Administrative Law Judge (ALJ) for hearing and decision. The ALJ is not bound by the optional fine set forth above.

MOTOR CARRIER COMPLAINT

The Pennsylvania Public Utility Commission (“Commission” or “PUC”) is a duly constituted agency of the Commonwealth of Pennsylvania empowered to regulate public utilities within the Commonwealth. The Commission has delegated its authority to initiate proceedings which are prosecutory in nature to the Bureau of Investigation and Enforcement and other bureaus with enforcement responsibilities. Pursuant to that delegated authority and Section 701 of the Public Utility Code, the Bureau of Investigation and Enforcement - Motor Carrier Division hereby represents as follows:

1. That LYFT INC, Respondent, maintains its principal place of business at 185 Berry Street, Suite 5000, San Francisco, California, 94107.
2. That Respondent was issued a license by this Commission on February 9, 2017, at PUC Utility Code number 6416471, authorizing transportation of persons for compensation from one point to another within Pennsylvania in Transportation Network Company (“TNC”) service.
3. That Respondent, on May 1, 2025, permitted a certain 2022 Hyundai Tucson bearing NY registration number 152766V and having vehicle identification number the last 4 digits being 8864 to be operated by driver Umit Oztunc.

That the vehicle described in numbered paragraph 3 above was inspected on the date specified by PUC Motor Carrier Enforcement Officer Mia Fuller on Airport Boulevard, Findley Township, Allegheny County, PA. Officer Fuller determined that at the time of the inspection, the vehicle in question failed to possess a valid certificate of inspection and the driver of the vehicle in question was smoking.
4. That Respondent, by allowing a vehicle to be operated in TNC service without possessing a valid certificate of inspection in the vehicle, violated 66 Pa.C.S. §2606(c). The penalty for this violation is \$250.
5. That Respondent, by allowing a driver to operate a vehicle engaged in TNC service while smoking, violated 66 Pa.C.S. §2605(b)(9). The fine for this violation is \$250

WHEREFORE, the Bureau of Investigation and Enforcement hereby requests that the Commission fine LYFT INC the sum of five hundred dollars (\$500.00) for the illegal activity described in this Complaint and order such other remedy as the Commission may deem to be appropriate.
