Your answers should be verified per 52 Pa Code § 1.36. Accordingly, you must provide the following statement with your responses:



Request for Information

Each PUC application should be considered separate. Questions should be answered in a complete and well thought out manner while meeting regulation standards for proper evaluation. Responses such as, “No changes, same as the previous application...” are unacceptable as this application is a new request. No question should be considered optional.

1.) Question # 2 of the Verified Statement.

A statement of ownership is not requested here. We need you to list Ramseys Moving System, LLC’s relationship with other motor carrier companies here.

2.) Question # 3 of the Verified Statement.

For the record you need to describe your experience and elaborate on services provided to include the number of years under the company name and the Pa PUC authority number that you are indicating.

3.) Question # 4 of the Verified Statement.

A.) Please provide a clear description of where your vehicle will be parked in relation to the physical address.

B.) What are the plans for storing a shipper’s goods, if the move cannot be completed in one day?

C.) Please explain your plan to secure customer information.

D.) Do you have a FAX machine and internet connection for communication with customers?

E.) Will you be using regular landline telephones, cell phones, or both to maintain continuous communication with your drivers?

4.) Question #5 of the Verified Statement requires that you describe your hiring and employment policies.

You are expected to provide a plan that satisfies the requirements of the 52 Pa Code. Please review the requirements of the following chapters of 52 Pa Code and provide policies with revision specific to:

A.) 52 Pa Code § 31.134 - Criminal history. (Frequency of record check, disqualification of employment, and record retention)

B.) 52 Pa Code § 37.204, 49 CFR 391.11 - Age restrictions. (minimum age)

C.) 52 Pa Code § 37.204, 49 CFR 391.25 – Review of driver record. (frequency of driver record check)

D.) 52 Pa Code § 37.204, 49 CFR part 391.31 relating to training program.

What are the criteria for successful completion of training?

E.) 52 Pa Code § 37.204, 49 CFR 382 relating to controlled substances and alcohol use testing. Please give the names of companies you are considering conducting the drug/alcohol preemployment, post-accident, and random tests.

5.) Question #7 of the Verified Statement.

You failed to adequately answer these questions. Please explain in detail your periodic vehicle maintenance plan, and your system for ensuring your vehicles will continuously comply with applicable Pennsylvania vehicle equipment standards (67 Pa. Code, Chapter 175). You are responsible for knowing these rules and regulations related to the proposed service.

A.) How often will you service your vehicles?

B.) Who will be conducting PA certified vehicle inspections?

C.) Will you have a pre-trip and/or post- trip inspections?

Give a sample of the inspection checklists.

6.) Question #8 of the Verified Statement.

What steps have management implement to ensure continuous insurance coverage for all vehicles in provision of service to the public?

7.) Financial Position.

A.) You are required to provide a complete and dated balance sheet. The information must be comprised of information which is less than 6 months old and should consist of accurate

information and not rounded numbers or estimates. The information provided is also to be strictly limited to assets and debts held by the applicant (Ramseys Moving System, LLC) and not the individual member(s). Any property listed must be registered or titled to the corporation – personal property should not be included. Any assets which may need transferred to the applicant should happen prior to adding them to the balance sheet.

- B.) At this point it is expected that the company is fully funded and ready to commence operations. To fully assist the Commission in determining your financial fitness please provide current copies of bank statement(s) (account numbers may be redacted), and/or notarized/official statement(s) provided by bank officers (with their current contact information) of account balance(s) in the name of Ramseys Moving System, LLC.
- C.) Provide verifiable proof of ownership with a copy of a title and/or registration for any claimed property and vehicle(s) in the name of Ramseys Moving System, LLC.

- **It is the responsibility of the applicant seeking motor common carrier authority to demonstrate that it possesses the financial ability to provide the proposed service.**
- **As per 52 Pa. Code §41.14, applications may be denied if the applicant fails to satisfy fitness standards.**

Note: It is in your best interest to provide accurate, complete, and timely responses. Be advised that additional corrections may not always be requested; therefore, prior to submitting your responses, your consultation with an attorney or financial expert familiar with Commission regulated Motor Carrier related proceedings is highly encouraged.
