

**STATUS REPORT**

TO THE PENNSYLVANIA PUBLIC UTILITY COMMISSION:

Duquesne Light Company (“Duquesne Light” or the “Company”) submits the following Status Report to Special Agent Michael J. Mroczka (“Special Agent”). Duquesne Light has been authorized to present this Status Report on its behalf as well as on behalf of Clovernote Holdings, LLC (“Clovernote”) and Hudson Energy Services, LLC (“Hudson”) (collectively the “Parties”).

**I. Introduction**

On May 9, 2025, the Parties participated in a Prehearing Conference presided over by the Special Agent. At the Prehearing Conference, the Parties agreed to suspend the litigation schedule in this matter to gather information and discuss settlement. Also on May 9, 2025, the Special Agent issued an Interim Order Suspending Litigation Schedule, which suspended the litigation schedule and required the Parties to file monthly status reports on the last business day of every month, until this matter is resolved by settlement, or a hearing or prehearing conference is requested. On May 30, 2025, the Parties submitted their first status report.

## **II. Status Report**

To date, Hudson has served informal discovery requests on Duquesne Light and Clovernote requesting information related to Clovernote's account and billing history. Duquesne Light is working with Clovernote to produce this information for Hudson and intends to submit responses to the requests by July 15, 2025. As such, the Parties respectfully request additional time to continue exchanging information and pursuing settlement, and to provide another status report on July 31, 2025.

## **III. Conclusion**

WHEREFORE, Duquesne Light Company, Clovernote Holdings, LLC, and Hudson Energy Services, LLC jointly request that the Special Agent Michael J. Mroczka accept this Status Report as the Parties continue to work together to resolve this matter.
