

**UNOPPOSED MOTION FOR CONTINUANCE  
OF AQUA PENNSYLVANIA, INC.**

Aqua Pennsylvania, Inc. (Respondent, Aqua or Company), by and through its attorneys, Reger Rizzo & Darnall LLP, and pursuant to 52 Pa. Code § 1.15, hereby moves that the Honorable Marta Guhl (Judge Guhl) of the Pennsylvania Public Utility Commission (Commission) issue an order continuing the Call-in Telephonic Hearing scheduled for August 27, 2025 (Hearing) as one of the Company’s fact witness, Heather S.D. Harrison, has a long-planned out of state vacation and is unavailable for the scheduled continued hearing.

In support thereof, FirstEnergy avers as follows:

1. On April 14, 2025, Patrece Glenn (Complainant) filed a Formal Complaint against Aqua disputing the lawful termination of service provided to 1206 Calcon Drive, Sharon Hill, Pennsylvania (Service Address).
  
2. On May 12, 2025, the Company filed an Answer and New Matter denying the material allegations therein.

3. By Notice, dated June 20, 2025, an Initial Call-In Telephonic Hearing was scheduled for Wednesday, August 27, 2024, before Judge Guhl.

4. 52 Pa. Code § 1.15 (b) states:


(b) Except as otherwise provided by statute, requests for continuance of hearings or for extension of time in which to perform an act required or allowed to be done at or within a specified time by this title or by order of the Commission or the presiding officer, shall be by motion in writing, timely filed with the Commission, stating the facts on which the application rests, except that during the course of a proceeding, the requests may be made by oral motion in the hearing before the Commission or the presiding officer. Only for good cause shown will requests for continuance be considered. The requests for a continuance should be filed at least 5 days prior to the hearing date.

5. The unavailability of the Company's fact witness, Heather S.D. Harrison, constitutes good cause consistent with Commission regulation.

6. On July 1, 2025, the undersigned counsel spoke with the Complainant *via* telephone to notify her of the Company's need for a continuance of the scheduled hearing. The Complainant stated that she does not object to the Company's requested continuance.

7. The Company respectfully requests the Call-in Telephonic Hearing be rescheduled for a date after August 27, 2025.

**WHEREFORE**, for good cause shown, Aqua Pennsylvania, Inc. requests that the Honorable Marta Guhl grant its Motion for Continuance of the scheduled August 27, 2025, Initial Call-In Telephonic Hearing.
