
Subject: Petition for Reconsideration from Staff Action - Amend

Dear Secretary,

I, Jose L Rivera, am requesting a petition to amend the application of 'Household Goods in Use' that was submitted on May 22, 2025, for the following reasons:

1. The original application for Property Carrier, was the application that was intended, but a letter received suggested it was amended to the Household Goods in Use application. At that moment, I was unaware of the difference, and I believe that based on the questions answered on my behalf, some confusion set in on the real intention, which resulted in the submission of the Household Goods in Use application with the additional \$250 fee to cover the difference. After speaking with David on June 18, 2025, and explaining the intention of transport, he suggested another petition of amendment be sent to reverse the first amendment. I would like to state that the application I wish to continue forward with is the Property Carrier application.
2. When the amendment was made, an additional \$250 was sent to cover the difference from the Property Carrier fee, which is \$100. I am requesting a refund of \$250 as that application is not the correct one, and I was guided erroneously by your office to change the original application.
3. In case the first application is missing, I have attached another application for your review. Nothing has changed from the original one completed in March 2025 to today.

I, Jose L Rivera, hereby state that the facts above set forth are true and correct (or are true and correct to the best of my knowledge, information and belief) and that I expect to be able to prove the same at a hearing held in this matter.
