EXCEPTIONS REGARDING INITIAL DECISION

1. I, Jonathan DiBello, am the Complainant in this case.
2. I, Jonathan DiBello, hereby respectfully disagree with the Initial Decision of F. Joseph Brady, Administrative Law Judge, which was entered on June 12th 2025
3. The last day I am allowed to file Exceptions is July 2nd 2025.
4. My Exceptions to the Initial Decision is as follows:

A previous case regarding PECO's refusal to give me a payment arrangement was filed by me with the PUC on 07/19/2023 (Reference PUC case# C-2023-3041825).

On 12/07/2023, the PUC ruled in the favor of PECO affirming that due to a Bankruptcy proceeding that I was ineligible for a payment arrangement. The PUC also refused to provide me with a payment arrangement.

In response to the final ruling from the PUC, to appeal their decision on January 5th 2024, I filed a case with the Commonwealth Court of Pennsylvania regarding this ruling disagreeing with the PUC's final ruling which as of 07/02/2025 is still pending. (Reference Commonwealth Court Case# 159 cd 2024)

I reaffirm that I am still proceeding with the Commonwealth Court case.

In April of 2025, I received a "10 Day Shut Off Notice" from PECO. I spoke to them regarding the situation and they stated to reach out to the PUC which I did.

I then attempted to file an informal complaint with the PUC for which I was denied prompting myself to file the current formal complaint.

In accordance to Pennsylvania law, I am allowed a stay from the shut off until the case has reached it's full conclusion for which it has not as I am appealing and continue to appeal the Final decision for which the PUC has ruled on. Therefore I remain eligible for a stay from shut off as I have the right to electricity which is a necessity and not a luxury.

WHEREFORE, I request that my Exceptions be granted.
