PHILADELPHIA GAS WORKS' MOTION TO CONTINUE

Pursuant to 52 Pa. Code §1.15, Philadelphia Gas Works (“PGW”) hereby files this Motion to Continue the evidentiary hearing in this matter, which is scheduled for Thursday, July 10, 2025. In support of this Motion, PGW states as follows:

1. By notice dated June 9, 2025, the Commission scheduled a hearing in this matter for Thursday, July 10, 2025 at 10:00 a.m., before Administrative Law Judge Emily A. Farren.
2. Pursuant to 52 Pa. Code §5.231(a) and the Prehearing Order issued on June 9, 2025, PGW is working with the Complainant to reach a resolution in this matter.
3. The parties have communicated regarding working to resolve the matter; however, the parties have not yet reached an agreement.
4. PGW and the Complainant need additional time to attempt to resolve this matter.
5. PGW has spoken with Ms. Brenner to discuss this request to continue the hearing.
6. Ms. Brenner has stated that she has no objection to PGW’s Motion. Ms. Brenner also stated that July 12th through July 19th are not good dates for her.
