1. Previously you provided sworn statements (verified per 52 Pa Code § 1.36) in which you stated that Megan Alvarez was a member of your management team and implied that her experience played a significant role in the applicant's ability to provide safe, efficient, and reasonable service. However, most recently, you have provided information which indicates that Ms. Alvarez was not actually an employee or part of the management structure of the applicant at all, but rather an independent consultant requiring a 1099.

Please explain the discrepancy in the two sworn positions, and a statement explaining how the previously sworn statements did not include intentionally false information.

Megan has experience with transportation, with Megans experience she was hired to consult and assist with a start up as a 1099 employee. Once the startup was complete Megan's role would also support daily operations and billing. Although I am well versed in creating routes, manifests, billing, policies and procedures per childcare regulations, Megan's was contracted to support Greater Work Transit transition into the non medical emergency transportation business. My previous sworn statements did not include intentionally false information. Megan has supported creating policies and procedures for my company. Megan has also assisted with providing information to obtain contracts, with the intent to provide a safe and reasonable service. As stated before, I currently operate my transportation company per childcare regulations as children/students are my only clients at the moment. The attempt to obtain the PUC license began in March, and at the moment I did consider Megan a part of my management team rather she was paid with a 1099 and or added to payroll at a later time. My definition of a manager is a senior professional who collaborates with owners and operators to establish and achieve business goals. Megan's role was to consult and manage operations that ensured Greater Work Transit grew effectively. Megan Alvarez supported resource allocation, policies and procedures, and risk management until separation in June.

2. Previously you were requested to provide a current copy of both Tierra Carroll's and Megan Alvarez's drivers' license, or other government issued identification (for verification purposes). As Ms. Alvarez is not, and was not, an actual employee of the company her information will no longer be required; however, Ms. Carroll's information still has not been submitted. Please provide the previously requested information.
