**PREHEARING CONFERENCE ORDER**

You are receiving this order because you have been identified as a person who may have an interest in the proceedings filed with the Pennsylvania Public Utility Commission (“Commission” or “PUC”) listed in the caption above. This order will describe the process the Commission will follow in considering these applications and/or Petition, the different options you may have for involvement, and how to become a party to this case. There is no requirement that you participate; however, if you do not, then the case will proceed and be decided without your input.

**Application Summary**

On April 11, 2025, Mid-Atlantic Interstate Transmission, LLC (“MAIT” or “Applicant”) filed an Application pursuant to 52 Pa. Code § 57.74(c) for approval by the Commission of the siting and construction of “Piney-Seward 115 Kilovolt (“kV”) Transmission Line Rebuild Project” (“Project”). The Project proposes to rebuild a

collection of five 115 kV transmission line segments totaling approximately 66 miles in length located in Piney, Monroe, Limestone, Porter, Redbank, Ringgold, Timblin, West Mahoning, North Mahoning, East Mahoning, Rayne, Green, Pine, Buffington, East Wheatfield, and St. Clair Townships, which are located in the following counties: Indiana, Westmoreland, Armstrong, Jefferson, and Clarion. The Project's stated goal is to address known reliability concerns and deteriorating conditions on the transmission line segments that have caused the lines to have a history of unplanned outages. Subject to Commission approval, construction of the Project is scheduled to begin on or about January 10, 2027, to meet an in-service date of July 31, 2029.

In Clarion County, the Project crosses the following townships: Piney Township is crossed by approximately one mile of 100-foot-wide right-of-way ("ROW") that is located on the far eastern side of the township running north to south; Monroe Township is crossed by approximately 5.2 miles of 100- to 250-foot-wide ROW that is located within the northern portion of the township running northwest to southeast; Limestone Township is crossed by approximately 2.7 miles of 180-foot-wide ROW that is located on the southwestern side of the township running northwest to southeast; Porter Township is crossed by approximately 0.3 miles of 180-foot-wide ROW that is located on the far eastern side of the township running northwest to southeast; and Redbank Township is crossed by approximately 5.8 miles of 180-foot-wide ROW that transects the township running northwest to southeast. In Armstrong County, the Project crosses Redbank Township by approximately 2.8 miles of 180-foot-wide ROW that is located on the northeastern side of the township running north to south.

In Jefferson County, the Project crosses the following townships and boroughs: Ringgold Township is crossed by approximately 2.8 miles of 120- to 180-foot-wide ROW that is located on the southwestern side of the township running north to south and is crossed again to the east of Timblin Borough for less than 0.1 miles of 120-foot-wide ROW running north to south; Timblin Borough is crossed by approximately

0.5 miles of 100- to 330-foot-wide ROW that is located on the eastern side of the borough running north to south; and Porter township is crossed by 4.2 miles of 180- to 215-foot-wide ROW that transects the township running north to south.

In Indiana County, the Project crosses the following townships: West Mahoning Township is crossed by approximately 4.4 miles of 100- to 180-foot-wide ROW that is located on the eastern side of the township running northwest to southeast; North Mahoning Township is crossed by approximately 1.8 miles of 180- to 215-foot-wide ROW that is located on the southwestern corner of the township running northwest to southeast; East Mahoning Township is crossed by approximately 7.3 miles of 180-foot-wide ROW that transects the township running north to south; Rayne Township is crossed by approximately 0.6 miles of 200-foot-wide ROW that is located on the northeastern corner of the township running north to south; Green Township is crossed by approximately 8.8 miles of 100- to 215-foot-wide ROW that transects the township running northwest to southeast; Pine Township is crossed by approximately 7 miles of 100- to 180-foot-wide ROW that transects the township running north to south; Buffington Township is crossed by approximately 6.5 miles of 180-foot-wide ROW that transects the township running north to south; and East Wheatfield Township is crossed by approximately 3.9 miles of 100- to 180-foot-wide ROW that transects the township running north to south. In Westmoreland County, the Project crosses St. Clair Township is crossed by approximately 0.9 miles of 100-foot-wide ROW that is located on the northern tip of the township running north to south.

The proposed Project contemplates rebuilding the five existing 115 kV line segments to a single circuit, 6-wire 115 kV configuration utilizing steel structures and requires the installation of approximately 336 new structures.

Formal protests and petitions to intervene must be filed in accordance with Title 52 of the Pennsylvania Code, **on or before July 31, 2025**. All filings must be made with the Secretary of the Pennsylvania Public Utility Commission, P.O. Box 3265, Harrisburg, PA 17105-3265, and with a copy served on Mid-Atlantic Interstate Transmission, LLC.

The Prehearing Conference is for the discussion and planning of the litigation of the case. No testimony will be taken. Lawyers representing parties of record and individual persons representing themselves as full litigants will be permitted to participate in the Prehearing Conference. The Prehearing Conference is open to the public. At the Prehearing Conference, the parties should be prepared to discuss all relevant issues related to this proceeding and any related proceedings, a litigation schedule, any request to consolidate this proceeding with other related proceedings, any objections to Protests or Petitions to Intervene, and the scheduling of public input hearing(s) or any other appropriate requests or proceedings to be conducted prior to the evidentiary hearing.

In response to this Prehearing Order, you may proceed in one of three ways:

- (1) Do nothing.** If you do nothing after receiving this Prehearing Conference Order, your name will be removed from the service list. After the Prehearing Conference, you will not receive any pleadings, filings, discovery requests, written testimony or orders and decisions in this matter. The parties are further directed to comply with the following requirements:

1. Each party must prepare and distribute a prehearing memorandum which sets forth a brief history of the proceeding, the issues you intend to present, a listing of your proposed witnesses and the subject of their testimony, and a list of any exhibits or documents you intend to present at the hearing in this proceeding **on or before 10:00 a.m. on July 29, 2025**. Prehearing memoranda shall also include a proposed litigation schedule. *The parties are expected to confer and attempt to agree to a proposed litigation schedule in advance of the prehearing conference*, to include proposed times, dates and locations of any evidentiary hearings, proposed public input

hearings as agreed to by all parties if possible, and any other proposed or requested proceedings to be conducted prior to the evidentiary hearing. The undersigned may be served with a copy of prehearing memoranda by email at [callenswor@pa.gov](mailto:callenswor@pa.gov). Parties represented by multiple attorneys should designate in their prehearing memorandum a lead representative for the purposes of the prehearing conference and the telephone number that legal counsel or any unrepresented Parties intend to use to call into the Prehearing Conference, if possible.

2. Please review the regulations pertaining to prehearing conferences, 52 Pa. Code § 5.221-§ 5.224, and in particular, § 5.222(d) which provides, in part:

(d) Parties and counsel will be expected to attend the conference fully prepared for a useful discussion of all problems involved in the proceeding, both procedural and substantive, and fully authorized to make commitments with respect thereto.

3. Parties should review the regulations relating to discovery, specifically 52 Pa. Code § 5.331(b), which provides, *inter alia*, that “a party shall endeavor to initiate discovery as early in the proceedings as reasonably possible,” and 52 Pa. Code § 5.322, which encourages parties to exchange information on an informal basis. All parties are urged to cooperate in discovery and advise me at the prehearing conference as to discovery problems which have not been resolved. There are limitations on discovery and sanctions for abuse of the discovery process. 52 Pa. Code §§ 5.361, 5.371-5.372.

4. Pursuant to 52 Pa. Code §§ 1.21 & 1.22, if you are an individual, you may represent yourself, or you may be represented by an attorney licensed to practice law in the Commonwealth of Pennsylvania, or admitted *Pro Hac Vice*. However, if you are a partnership, corporation, trust, association, or governmental agency or subdivision, you must be represented in this proceeding by an attorney licensed to practice law in the Commonwealth of Pennsylvania or admitted *Pro Hac Vice*. Unless you are an attorney,

you may not represent someone else. Attorneys shall insure that their appearance is entered in accordance with the provisions of 52 Pa. Code § 1.24(b).

5. Failure of a party to attend the prehearing conference or notify the administrative law judges of their desire to fully participate without good cause shown, shall constitute a waiver of all objections to the agreements reached and matters decided at the prehearing conference, including, but not limited to, any special discovery rules and the litigation schedule established for this case. 52 Pa. Code §§ 5.222(e) & 5.224.

6. You must serve the presiding officer directly with a copy of any document that you file in this proceeding. If you send the undersigned any correspondence or document, you must send a copy to all other parties. For your convenience, a copy of the Commission's current service list of the parties to this proceeding is enclosed with this Order.
