MOTION FOR ENLARGEMENT OF TIME

Complainant, Roger Buehl, pro se, hereby seeks an enlargement of time, pursuant to 52 Pa.Code § 1.15, within which to submit an appropriate response or pleading.

In support hereof, Complainant submits:

1. Complainant (Buehl) is a state prisoner housed at a state correctional institution, where Respondent Global Tel\*Link provides various electronic messaging and media services.

2. On April 7, 2025, Buehl filed a formal Complaint before the PUC, seeking to obtain an accounting of prior purchases arising from a billing/refund dispute.

3. After seeking an extension of time, the Respondent filed its Answer on or about June 4, 2025.

4. A service copy of Respondent's Answer was mailed to Buehl, addressed to Smart Communications in St. Petersburg, Florida, the PA Department of Corrections' third-party mail-forwarding contractor. All mail sent to prisoners at said Smart Communications address is typically delivered 10 to 14 days after receipt.

5. Consequently, the served copy of Respondent's Answer was not delivered to Buehl until June 17, 2025.

6. Buehl intends to prepare and submit either an appropriate response, reply or an amended pleading, as provided for by law. See, 52 Pa.Code. § 5.63 (Replies), 52 Pa.Code § 5.91 (Amendment) and 52 Pa.Code § 5.101 (Preliminary Objections).

7. Buehl is not an attorney, and must rely on his own research efforts, and paralegal assistance provided by others. Although Buehl can access the facility law library on a limited basis, he does not have access to the research tools and incidental assistance available to most attorneys.

8. Because Buehl is proceeding pro se, he must research, prepare, copy and submit his own documents in this matter. Moreover, as a prisoner, Buehl's general access to the facility law library, paralegal assistance and photocopier is limited to three 90-minute sessions weekly.

9. Furthermore, previous PUC decisions (such as those cited in Respondent's submissions) are not accessible in the facility law library, and must be requested via interlibrary loan or obtained through the mail.

10. Accordingly, Buehl is unable to research, prepare, copy and submit his documents as quickly and easily as an attorney.

11. Buehl therefore requires approximately sixty (60) more days within which to submit an appropriate response or pleading in this matter.

12. Respondent Global Tel\*Link would not be prejudiced by the enlargement of time being sought herein.

WHEREFORE, the Complainant requests that the PUC grant an enlargement of time, until August 20, 2025, for him to submit an appropriate response or pleading.
