

NOTICE OF MOTOR CARRIER COMPLAINT

- A. You must file an Answer within twenty (20) days of the date of service of this Complaint. The date of service is the mailing date as indicated at the top of the Secretarial Cover Letter for this Complaint and Notice, 52 Pa. Code §1.56(a). An Answer is a written explanation of circumstances wished to be considered in determining the outcome. The Answer should raise all factual and legal arguments that you wish to claim in your defense and must include the reference number of this Complaint. Your Answer must be verified, and the original shall be **mailed to:**

- B. If you fail to answer this Complaint within twenty (20) days, the Bureau of Investigation and Enforcement will request that the Commission issue a Secretarial Letter imposing a penalty. The penalty could include a fine, the suspension or revocation of your certificate of public convenience or other such remedy.
- C. You may elect not to contest this complaint by paying the fine proposed in this Complaint by certified check or money order. **Payment must be made to the "Commonwealth of Pennsylvania"** and should be forwarded to:

- D. Your payment is an admission that you committed the alleged violation and an agreement to cease and desist from further violations. Upon receipt of your payment, the Complaint proceeding shall be closed.
- E. If you file an Answer, which admits or fails to deny the allegations of the Complaint, the Bureau of Investigation and Enforcement will request that the Commission issue a Secretarial Letter imposing a fine and/or other such remedy.
- F. If you file an Answer which contests the Complaint, the matter will be assigned to an Administrative Law Judge (ALJ) for hearing and decision. The ALJ judge is not bound by the optional fine set forth above.

MOTOR CARRIER COMPLAINT

The Pennsylvania Public Utility Commission (Commission or “PUC”) is a duly constituted agency of the Commonwealth of Pennsylvania empowered to regulate public utilities within the Commonwealth. The Commission has delegated its authority to initiate proceedings which are prosecutory in nature to the Bureau of Investigation and Enforcement and other bureaus with enforcement responsibilities. Pursuant to that delegated authority and Section 701 of the Public Utility Code, the Bureau of Investigation and Enforcement-Motor Carrier Division hereby represents as follows:

1. That PODK CORPORATION, Respondent, maintains its principal place of business at 270 East End Centre, Wilkes-Barre, PA 185702.
2. That Respondent was issued a certificate of public convenience for taxi authority on July 2, 2024, and limousine authority on September 20, 2024, by this Commission at Public Utility Code No. 6327108.
3. That on April 30, 2025, PUC Motor Carrier Enforcement Officer Neal Ebbert, arrived at Respondent’s address to discuss a complaint filed against Respondent. Officer Ebbert requested to see all driver and vehicle records. Respondent employs eight drivers.
4. That at the time of the inspection of the files, the files for all eight drivers were missing criminal histories in violation of 52 Pa. Code § 29.505(b). The penalty for this violation is \$100 per violation.

WHEREFORE, the Bureau of Investigation and Enforcement hereby requests that the Commission fine PODK CORPORATION, the sum of eight hundred dollars (\$800.00) for the illegal activity described in this Complaint and order such other remedy as the Commission may deem to be appropriate.
