

NOTE 5 - Minimum Transportation Charge: Sundays and Holidays (any hour): 2 hours plus applicable travel time charge at rates named in Columns 1 and 2. Saturdays (any hour): 2 hours plus applicable travel time charge at rates named in Columns 1 and 4. Weekdays (any hour): 2 hours plus applicable travel time charge at rates named in Columns 1 and 3. Please note that carrier will not assess a minimum or overtime charge when the move is performed solely at the convenience of the carrier.

NOTE 6 - When for the convenience of the customer, shipment is held overnight, the carrier will assess a fee of **\$150.00** per truck per night.
