Please be advised that any PUC correspondence addressed to me here, at my facility address (set forth above) must be sent as "official mail" pursuant to Department of Corrections policy. In order to send "official mail" to a prisoner, go to the DOC website (<https://privilegedmails.cor.pa.gov>) or contact the DOC central office by email (RA-CRatrnycntrinum@pa.gov) to request an "official mail" control number.

All courts and agencies use the "official mail" procedure. The alternative is to send official mail as general correspondence via the Smart Communications address (P.O. Box 33028, St. Petersburg, FL 33733) which normally entails a 10 to 14 day delay in delivery, occasional "lost" mail incidents, and does NOT permit delivery of any original documents.

Accordingly, this is to respectfully request that the PUC utilize the DOC "official mail" procedures to ensure timely (and verifiable) delivery of any communications and orders.

If you DO wish to appeal:

The inmate has 15 working days from the date on the Unacceptable Correspondence Form to notify the Facility Manager in writing, in accordance with the **DC-ADM 804**, and the sender has 15 working days to appeal, in writing, to the Facility Manager, which for the sender constitutes the only level of appeal. (See www.cor.pa.gov) The mailroom officer will hold the confiscated items until the appeal process is completed.

If you DO NOT wish to appeal:

The inmate has the option to forward a cash slip with an addressed envelope to the mailroom within 15 working days from the date of this decision to have the confiscated items mailed out of the facility or it will be destroyed. Material that cannot be legally mailed will be destroyed.
