Application of Columbia Gas of Pennsylvania for approval of the alteration of the crossing where State Route 0857 (Morgantown Street) crosses, at grade, a single track of Southwest Pennsylvania Railroad (Carload Express) (DOT 142 342 C) by the installation of an underground 6-inch plastic gas line encased in a 10-inch steel casing pipe in the Borough of Fairchance, Fayette County.
