Zaracare LLC

1. The office location is 1802 Bentley Drive, Apartment 302, Pittsburgh, PA 15219. This is my apartment. At this time, I am the only driver and will be operating from my apartment. The only office equipment I will initially use is my cell phone. I have one vehicle which will be housed in the apartment complex parking lot.
2. Zaracare LLC is a single member LLC. The single member is Sadiq Choumou Hagar.
  - a) I expect to be the only driver initially. I will hire additional drivers as needed to fulfill demand for services.
  - b)
    - i. No driver will be hired who is under the age of 21.
    - c.
      - i. A criminal background check will be conducted through the Pennsylvania State Police and every other state in which the prospective driver resided for the last 12 months. A national criminal background check will also be conducted for each prospective driver before hire. No driver shall be hired who has a conviction within the preceding 7 years for Driving Under the Influence of Alcohol, Theft, Fraud, or any violation of The Controlled Substance, Drug, Device and Cosmetic Act. No driver will be hired who has a conviction within the previous 10 years for any crime involving the use of a motor vehicle to commit a felony, or a conviction for Burglary or Robbery. No driver will be hired who has a conviction at any time for any sexual offense, a crime of violence, or an act of terror.
      - ii. A criminal history of each driver will be obtained every two years.
      - iii. A copy of the criminal history of each driver shall be maintained for five years.
      - iv. A paper and electronic file will be maintained for each driver for at least five years.
  - d) Each driver hired will be required to undergo a rigorous driver training program offered by a Pennsylvania Certified Driver Training School, which will include defensive driving techniques, sensitivity and passenger assistance training, emergency procedures and first aid basics.

- e) The driving record of each prospective driver will be obtained from the appropriate state agency for every state in which the prospective driver held a motor vehicle operator's license or permit during the preceding 3 years and reviewed. An updated driver history will be obtained at least every 12 months. No driver with more than 3 moving violation within the past 3 years or with any major violation within the past 3 years shall be hired or retained. Driving records will be maintained on paper and electronically for 5 years.
  - f) No driver may use alcohol, be under the influence of alcohol, or have any measured alcohol concentration or detected presence of alcohol while operating a vehicle in passenger service. No driver may use a controlled substance, be under the influence of a controlled substance, or have any measured concentration or detected presence of a controlled substance while operating a vehicle in passenger service.
3. a. In addition to periodically checking engine and oil changes, Zaracare will maintain official state inspections of each vehicle at least once a year. Any safety issue with any vehicle will be immediately addressed.
- b. Each vehicle will be inspected pre and post trip to ensure that there are no safety or mechanical issues. The inspection will include brakes, tires, lights, wipers, mirrors, fluid levels and seat belts.

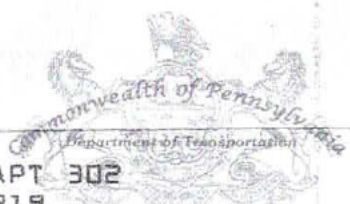

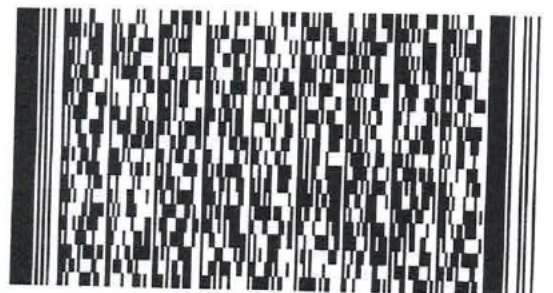
