REPRESENTATION. If you are an individual, you may represent yourself or you may have an attorney represent you. All others, including a partnership, corporation, trust, association, or governmental agency or subdivision, must be represented by an attorney licensed to practice law in Pennsylvania, or admitted *pro hac vice*. Only an attorney may represent someone else.

PRESENTING EXHIBITS. If you intend to present any documents or exhibits other than pre-served written testimony and exhibits at the hearing, you must email one (1) copy to the Presiding Officers at jcoogan@pa.gov and efarren@pa.gov and one (1) copy each must be sent to every other party. All copies must be received by Friday, October 10, 2025. Proposed exhibits should be properly pre-marked for identification purposes.
