Pursuant to 52 Pa. Code § 3.381, Newhurst, Inc., which holds a Group and Party license in Docket No. A-00093160, is submitting this letter notification to reflect its change in name from Newhurst, Inc. to Newhurst LLC, as part of a recent corporate restructuring. The company also recently realized an indirect change in control at the upstream parent corporate level; however, that change in control is not expected to impact day-to-day PUC-licensed Group and Party carrier operations and did not trigger Commission review. H.E. Rohrer, LLC is the owner of 100% of the membership interests of Newhurst LLC. Documentation from the Pennsylvania Department of State confirming the corporate name change is included in this filing. Newhurst LLC is comprised of the following officers:
