

SECTION 6

TRANSPORTATION RATES BASED ON WEIGHT & MILEAGE

Rates are in cents per 100 pounds, apply to actual weight (subject to minimum weights as provided in rules herein) and include loading and unloading and the actual movement or transportation of property from origin to destination, but do not include Additional Services and Charges shown in Section 1. These rates apply to moves traveling between points in Pennsylvania and transported in excess of forty (40) miles.

SECTION 3

ADDITIONAL SERVICES

The following charges (Notes 1 to 7) apply to shipments traveling between points in Pennsylvania and transported distances of forty (40) miles or less as well as shipments transported distances in excess of forty (40) miles.

NOTE 1 - When overnight holding of the shipment is requested by the customer for their convenience, an additional charge of **\$200.00** per vehicle/trailer per night will be assessed by the carrier. This charge does not apply when multiple days are required for the carrier to complete the move.

NOTE 2 - When there is excessive distance between the residence and the carrier's vehicle, a charge of **\$75.00** per each additional fifty (50) feet after the first seventy-five (75) feet will be in addition to all other applicable charges.

NOTE 3 - When stairs are present at origin or destination (2nd floor or higher), an additional charge of **\$50.00** per flight will be assessed by the carrier.

NOTE 4 - On shipments with an elevator at origin or destination, an additional flat charge of **\$50.00** per elevator will be applied.

NOTE 5 - If an item deemed by the carrier to be a bulky item (i.e. pianos) are included in the shipment, the carrier will apply an additional charge of **\$150.00** per each bulky item.

NOTE 6 - When other special services (3rd Party services, etc.) are required, the estimated cost will be quoted in advance and added to the final charges.

NOTE 7 - If additional labor is required on shipments traveling between points in Pennsylvania and transported in excess of forty (40) miles, a charge of **\$75.00** per man per hour will be assessed by the carrier. This charge is in addition to all other applicable charges.
