PRE-REGISTRATION INFORMATION: Whether pre-registering by email or telephone, in both cases, provide the following information:

- (2) which hearing you are registering for
- (3) the phone number you will be using to call into the telephonic public input hearing
- (4) a phone number where you can be reached prior to the hearing if we need to contact you, and
- (5) your email address, if you have one

NEED ASSISTANCE WITH PRE-REGISTRATION? If you need assistance pre-registering to testify, you may have someone register for you, but they will need to provide the PUC Judges with all the information listed above. Additionally, if more than one person in your household would like to testify, one person may pre-register for other individuals in the same household by providing the PUC Judges' Legal Assistant with the above-listed information for each individual.

REQUESTS FOR INTERPRETERS: If you require an interpreter, please make your request when you pre-register as soon as possible. If you register too close to the hearing date, we may not have enough time to arrange for an interpreter. If you request an interpreter, the PUC will make reasonable efforts to have one present.
