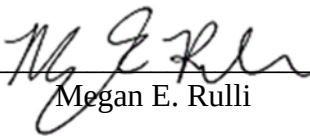

STATUS REPORT

TO THE PENNSYLVANIA PUBLIC UTILITY COMMISSION:

Duquesne Light Company (“Duquesne Light” or the “Company”) submits the following Status Report to Special Agent Michael J. Mroczka (“Special Agent”). Duquesne Light has been authorized to present this Status Report on its behalf as well as on behalf of Clovernote Holdings, LLC (“Clovernote”) and Hudson Energy Services, LLC (“Hudson”) (collectively the “Parties”).

I. Introduction

On May 9, 2025, the Parties participated in a Prehearing Conference presided over by the Special Agent. At the Prehearing Conference, the Parties agreed to suspend the litigation schedule in this matter to gather information and discuss settlement. Also on May 9, 2025, the Special Agent issued an Interim Order Suspending Litigation Schedule, which suspended the litigation schedule and required the Parties to file monthly status reports on the last business day of every month, until this matter is resolved by settlement, or a hearing or prehearing conference is requested. On May 30, and July 1, 2025, the Parties submitted status reports.

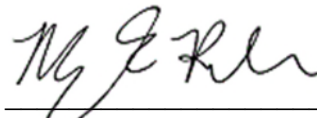
II. Status Report

Since the last status report, Duquesne Light and Clovernote have provided responses to informal discovery requests from Hudson. The Parties are continuing to exchange information and are working to resolve the issues raised in the Complaint. As such, the Parties respectfully request additional time to exchange information and pursue settlement, and to provide another status report on August 29, 2025.
