To Whom It May Concern:

On October 21, 2024, the Bureau of Investigation and Enforcement within the Pennsylvania Public Utility Commission instituted a Complaint at C- 2025-3051731 against Canyon Country Cabs LLC (Company), alleging that Company vehicle no. 10 had steer axle tires with less than 2/32" tread remaining at any point. The Complaint alleged that by operating a vehicle with two front tires that did not comply with safe operating conditions, the Company violated 52 Pa. Code § 29.402(1); 67 Pa. Code § 175.65. The penalty for this violation is one hundred dollars (\$100.00) per violation for a total of \$200.00. The Complaint further alleged that Company vehicle no. 10 and Company vehicle no. 12 were operated with expired registrations in violation of 52 Pa. Code § 29.402(1); 67 Pa. Code § 175.80. The penalty for this violation is one hundred dollars (\$100.00) per violation for a total of \$200.00.

The Complaint notified Respondent that it must file an Answer in accordance with 52 Pa. Code § 5.61, within twenty days of the date of service. The Notice further specified that, if Respondent failed to answer the Complaint within twenty days, the Bureau of Investigation and Enforcement would request the Commission to issue a letter fining Respondent the sum of \$400.00.

The Complaint was sent to the Company at its registered address by certified mail on March 14, 2025. The Complaint was served on April 8, 2025. To date, no response has been received from Canyon Country Cabs LLC.

Canyon Country Cabs LLC is hereby assessed a fine of \$400.00 for failure to comply with the provisions of the Public Utility Code and the Commission's implementing regulations. Payment must be made by certified check or money order payable to the Commonwealth of PA,

and mailed to PA Public Utility Commission, 400 North Street, Harrisburg, PA 17120. If payment in full is not received by the Commission on or before July 14, 2025, the Company will be subject to any of the following: (1) interest on outstanding fine amounts; (2) suspension or revocation of its certificate of public convenience (CPC); and/or (3) suspension of registration with the Pennsylvania Department of Transportation (PennDOT) for one or more of the Company's vehicles.

Respondent is hereby notified to cease and desist from further violations of the Public Utility Code, 66 Pa. C.S. §§ 101 et seq. or the regulations of the Commission, 52 Pa. Code §§ 1.1 et seq.

If you disagree with this determination you may appeal to the Commission, pursuant to 52 Pa. Code § 5.44 or, if you believe that you have received this letter in error, you must write a letter stating the reasons you believe this letter is in error and requesting that it be rescinded within twenty (20) days of the date of this letter. The letter shall be sent to Secretary, PA Public Utility Commission, 400 North Street, Harrisburg, PA 17120.
