Dear Secretary Homsher:

In accordance with the Pennsylvania Public Utility Commission's ("PUC" or the "Commission") December 20, 2024 Opinion and Order, Ordering Paragraph 7, entered at the above docket ("Order"), Aqua Pennsylvania Wastewater, Inc. ("Aqua") is providing the following information regarding Aqua's Customer Assistance Program ("CAP").

In order to inform the former Greenville Sanitary Authority ("GSA") customers of Aqua's CAP, a flyer promoting the program was included in the welcome letter sent to the GSA customers following closing of the acquisition as required by Ordering Paragraph 6. To further promote the program, all GSA residential customers received a bill insert in their February invoices (see Ordering Paragraph 6). A copy of the insert is included with this letter.

As of July 23, 2025, nine (9) Greenville customers are actively enrolled in the CAP. Aqua recently established outreach goals with its stakeholder advisory group, the Aqua Assistance Collaborative ("AAC"). These outreach goals included targeted outreach to customers of recently acquired systems, including GSA. Aqua will report on GSA enrollment at its upcoming AAC meeting to be held August 20, 2025, and on an ongoing basis up to the conclusion of Aqua's next base rate case as required by the Commission's Order.
