RULES AND REGULATIONS

ITEM 1: ADVANCE RESERVATIONS

Advance Reservations must be made 24 hours prior to the service being rendered.

ITEM 2: CONTRACT SERVICES

Contract service provided will be for a term of not less than 30 days for prequalified persons under a federal, state, county or municipal governmental agency contract. Rates for such services will be specified in the respective contracts, copies of which, including any amendments thereto, are to be filed with the Commission as executed to become effective on one days notice.

ITEM 3: RATES

Rates will be calculated by the odometer of the vehicle used and will be calculated from garage to garage.

ITEM 4: PAYMENT OF OUT OF POCKET EXPENSES

All tolls, parking fees and other out of pocket expenses shall be the responsibility of the customer and will be added onto carrier's charge

ITEM 5: PROMOTIONAL FARES

Upon presentation of advertising coupon or special promotional offer, carrier will offer rates at specified discount from the published Tariff rates on dates authorized by the coupon or special promotional offer. Advertised coupon or promotional offer will be filed with the Public Utility Commission prior to publication/broadcast. Coupons will be published and promotional offers will be broadcast in one or all of the following: Local Newspaper, Flyers and other printed material, all forms of radio and television advertising media including internet and display advertising
