Request for Information

- 1.) Your previous authority was Paratransit, but your most recent application is for Group and Party 11-15 service. The Group and Party 11-15 authority is for special excursions, tours, and sightseeing with exclusive or nonexclusive service.
 - A.) To be clear, please verify with a statement that Group and Party 11-15 is the correct authority you want to acquire.
 - Please see if Paratransit reflects the service you intend to provide. Applications can be found on the Commission's website at the following address <https://www.puc.pa.gov/filing-resources/forms/motor-carrier-forms/>.
 - B.) After you have thoroughly reviewed the different authority types. If you feel that you have applied for the wrong authority, then you will need to make a statement that you wish to amend the authority type, submit along with a complete application for said authority type.
- 2.) Please provide a photocopy of Ramon Vasquez's driver's license or a government identification card for verification purposes. The provided document must be government issued, feature a clear picture, and include the legal name, current address, and date of birth.
- 3.) This office has no record that the past due amount of \$184.00 in assessments was paid and processed. Provide proof this amount was paid.

4.) Financial Position

- A.) The bank statement's ending balance and the balance sheet's cash asset amount contradict. Please explain the contradiction and correct the balance sheet to match an improved bank statement.
- B.) Based on the bank statement's end balance of \$200.88, your cash assets have decreased. The applicant will be given one last opportunity to provide evidence that it is financially able to provide its proposed service. To show improved financial fitness you should have a substantial amount in your ending balance.
- C.) What is your back up plan if your only vehicle is out of service?
- If you find that you need to build capital to carry on safe and reliable service to the public, then you should withdraw your application. Please know you may reapply later.

Note: It is in your best interest to provide accurate, complete, and timely responses. Be advised that additional corrections may not always be requested; therefore, prior to submitting your responses, your consultation with an attorney and/or financial expert familiar with Commission regulated Motor Carrier related proceedings is highly encouraged.
