TO THE PENNSYLVANIA PUBLIC UTILITY COMMISSION:

NOW COMES, Global Tel*Link Corporation d/b/a ViaPath Technologies (“ViaPath”), by and through its attorneys, Susan E. Bruce and Kenneth R. Stark, pursuant to 52 Pa. Code § 5.24, and certifies the following:

1. Complainant is Roger Buehl, an incarcerated individual currently housed in the Pennsylvania Department of Corrections (“DOC”) facility at Somerset, who purchased non-regulated, non-jurisdictional content (music/songs) to use on his personal tablet device issued by the DOC.

2. This Certificate of Satisfaction is submitted pursuant to 52 Pa. Code § 5.24(b).

3. ViaPath hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission (“Commission” or “PUC”) have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding, and Complainant has acknowledged satisfaction to representatives of ViaPath.

4. Respondent hereby notifies Complainant of the filing of this Certificate of Satisfaction, and that if Complainant objects or disagrees with the terms of this Certificate of Satisfaction, he must notify the Commission in writing of his objection and/or disagreement within

thirty (30) days of the date that this Certificate of Satisfaction was signed and served (and no later than July 21, 2025), or the terms of the Certificate of Satisfaction will become final and binding.

5. In order to settle this matter without further action, ViaPath has provided a credit in the amount of \$28.43 to Complainant's account used to purchase content on his tablet device.

6. The above-captioned Formal Complaint of Roger Buel c/o Smart Communications against Global Tel*Link Corporation d/b/a ViaPath Technologies is now satisfied.

7. The parties therefore request that the hearing scheduled for August 12, 2025 be cancelled given satisfaction of the Formal Complaint.
