We are counsel for Aqua Pennsylvania, Inc. (“Aqua” or “Company”) in the above-referenced Application proceeding and hereby submit this verification letter evidencing satisfaction of the conditions set forth in your letter dated June 30, 2025, conditionally accepting the Application for filing (“Conditional Acceptance Letter”).

In compliance with the Conditional Acceptance Letter, we are submitting the following items:

1. A Certificate of Service verifying service of the Application upon the affected entities between July 23rd and July 29th, 2025;¹ and
2. A proof of publication of the notice of the Application published in *The Record Argus* on July 23, 2025 and July 30, 2025.

In further compliance with the Conditional Acceptance Letter, Aqua and the Municipal Authority of the Borough of Greenville (“GWA”), respectively, concurrently provided individualized notice of the proposed acquisition to all potentially affected customers.² Aqua’s provision of notice to its customers was completed on August 4, 2025, and GWA’s notice was completed on July 31, 2025.

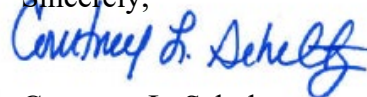

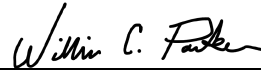
