**INTERIM ORDER
ATTACHING LATE-FILED EXHIBIT TO RECORD AND CLOSING RECORD**

An evidentiary hearing in the above-captioned matter convened on August 5, 2025. Complainant appeared *pro se* and the Company was represented by counsel. Complainant testified on his own behalf and did not offer any exhibits. The Company offered the testimony of one witness, and the Company’s Exhibits 1-11 were admitted into the record. During the hearing, I directed the Company to submit an additional exhibit, FE PA Ex. 12, as a late-filed exhibit.
