**INTERIM ORDER
ON JOINT MOTION TO STRIKE**

On July 30, 2025, Wellsboro Electric Company and Citizen’s Electric Company of Lewisburg (collectively, Companies) filed a motion to strike portions of the Direct Testimony of Kevin Lucas, which was served on behalf of Kelly Road Solar, LLC, Lancaster Avenue Solar, LLC, and Twilight Renewables, LLC (collectively, Solar Projects). Mr. Lucas’ testimony, identified as Solar Projects Statement No. 2, was served to the parties in this proceeding on July 15, 2025, in support of Solar Projects position in the Citizen’s Electric base rate proceeding at Docket R-2025-3054394.

The Companies object to references in the written testimony to Wellsboro Electric Company because Solar Projects is not a party in the Wellsboro base rate proceeding. According to the Companies the references to Wellsboro Electric should be stricken because these statements are not relevant to Citizen’s base rate filing.

Solar Projects filed a response to the motion on August 7, 2025. Solar Projects observes that witnesses routinely compare tariffs in base rate proceedings and that the witness’s comparison of nearly identical provisions in both Wellsboro and Citizen’s filings are relevant and should not be stricken. Solar Projects observes that Commission proceedings are not bound

by strict compliance with the Pennsylvania Rules of Evidence and that administrative law judges are vested with the authority to make a determination regarding the weight of evidence that is admitted into the record.

Upon consideration of the Companies' argument and the response of Solar Projects, the Companies' motion to strike portions of Solar Projects Statement No. 2 is denied.

THEREFORE,

IT IS ORDERED:

That the Joint Motion to Strike Portions of Solar Projects' Statement No. 2 served on July 15, 2025, is denied.
