Dear Secretary Homsher:

I am writing to you in regard to the status of my complaint, as to my present awareness.

I filed a complaint against Windstream Holdings because I could not get anyone with their firm to address my questions or acknowledge their responsibility for telephone poles placed on my property.

The issue was that Windstream had placed telephone poles on my property for services to an adjacent lot, without approval to do so. The poles were placed along Cross Road Blvd S.R. 2002 and then crossed my property to a residence on the lot west of mine. The resident on that lot sold their property in 2017, to the family of a plot owner immediately south, plot 73, of theirs, and all utility service was discontinued at that time, and there is no residence on the property. I place a locked gate on the narrow dirt roadway to lot 71, in 2020 to restrict any use of that roadway. No one has requested use of that roadway in the past five years.

After several email communications with the Windstream legal representative, Paula Anderson, in which I provided evidence of my co-ownership of the Plot 72 in Beccaria Township, Clearfield County, PA, and provided her with means to contact the present owner, Mr. Diven, of the adjacent Plot 71, who could confirm no service required by Windstream; I was told on July 1, by email from P. Anderson, that Windstream was going to remove the poles at issue.

I emailed Attorney Anderson twice after her notification of planned pole removal, to determine the status of removal, but got no reply.

On July 21, I called Attorney Anderson, to determine if she had received my inquiries, and she said she had, but didn't contact Mr. Diven yet. She said she would call her supervisor to see what to do now. As of this date, I have not heard from her.

One of the concerns about the unapproved poles, is that I am presently responding to the BCI Municipal Water Authority's request for a water pipeline easement across my property, and the telephone poles along S.R. 2002 are inside the water utility proposed easement route. I have an attorney negotiating the BCI easement agreement.

I have no legal advisor in regard to my PUC complaint, I am an 85 year old retired businessman who along with my wife care for a disabled adult, 63, son who is bed ridden and has aphasia requiring 24/7 care, and it is difficult to keep-up all of the contacts required by these property issues.

Your consideration of my circumstance will be appreciated.
